### Supply of a 165 kW Solar Power System under Net Accounting Scheme

1. Sealed bids are invited by the Director General of the Sri Lanka Institute of Textile and Apparel for design, transport, supply, installation, commissioning and maintenance of a Solar Power System under Net Accounting Scheme.
2. All bidders should have been registered with the Sri Lanka Sustainable Energy Authority and should be institutions having more than five (05) years experience in designing, supplying, installing, commissioning and maintenance of Solar Power Systems.
3. Bids will be conducted through National Competitive Bidding Procedure.
4. Bid documents may be inspected on working days of the week (between 9.00 and 3.00 p.m.).
5. All bidders should submit an unconditional, On Demand bid security drawn in favour of "Director General to the value of Rs. 310,000/- obtained from a reputed commercial bank in Sri Lanka approved by the Central Bank of Sri Lanka valid from 08.02.2024 until 28.06.2024.

Interested bidders may obtain a complete set of bid documents in English language between 9.00 a.m. and 3.00 p.m. on working days from 08.02.2024 until 27.02.2024 on submission of a written application on a letterhead to the Director General, Sri Lanka Institute of Textile and Apparel, No. 02, Kandawala Estate, Ratmalana upon payment of a nonrefundable fee of Rs. 7,500.00 to the Accounts Division.

Sealed bids in duplicate may either be sent by registered post addressed to Director General, Sri Lanka Institute of Textile and Apparel, Ratmalana or deposited in the Tender Box kept in the Administration Division of the institution mentioning the "Procurement No. and Net Accounting Scheme Solar Power System" on the left hand top corner of the envelope containing the bid.
8. Bids should be valid up to 28.07.2024 from the date of closing of bids.
9. Pre-bid meeting will be held at 3.00 p.m. on 14.02.2024 at the Meeting Hall of the Sri Lanka Institute of Textile and Apparel, No. 02, Kandawala Estate, Ratmalana.
